

ADVISORY INFORMATION

IMPORTANT: When applying this product under the terms of this Extension of Authorisation, comply with any resistance guidance or restrictions stated on the product label.

Total reliance on one pesticide will hasten the development of resistance. Pesticides of different chemical types or alternative control measures should be included in the planned programme. Alternating with different modes of action is a recognised anti-resistance strategy.

This Extension of Authorisation relates to the use of 'Amylo X WG' (M17978) the below named crops for the control of Scerotinia spp, Botrytis cinerea, Stemphylium botryosum, Anthracnose (Colletotrichum spinaciae), Cercospora (Cercospora beticola), Pseudomonas spp, Xanthomonas spp, Downy mildew, Powdery mildew including Podosphaera aphanis and Golovinomyces spp, Damping off disease including Pythium sp, Rhizoctonia sp and Fusarium sp. The product should be applied in broadcast air blast sprayers, hydraulic pressure sprayers or hand- trailed lance sprayers in a water volume of 200-1500 litres. Applications to be made from March to October for outdoor crops and all year round for protected crops with a 7 day interval between applications.
