ADVISORY INFORMATION

IMPORTANT: When applying this product under the terms of this Extension of Authorisation, comply with any resistance guidance or restrictions stated on the product label.

Total reliance on one pesticide will hasten the development of resistance. Pesticides of different chemical types or alternative control measures should be included in the planned programme. Alternating with different modes of action is a recognised anti-resistance strategy.

Coragen contains the active chlorantraniliprole, a maximum of two applications per year of chlorantraniliprole are permitted.

This Extension of Authorisation relates to the use of 'Coragen' (M14930) ' as an insecticide for use on lettuce, baby leaf crops and fresh herbs for the control of caterpillars, specifically: Silver Y moth caterpillars (*Autographa gamma*) and Diamond Back moth (*Plutella xylostella*).

Application is to be made by conventional hydraulic or air assisted boom sprayers in a minimum of 100 litres of water with a seven day interval between treatments.

The best available application technique, which minimises off-target drift, should be used to reduce effects on non-target insects or other arthropods.
