


UK HUMAN AND INDUSTRIAL USAGE

KEY POINTS

- Wheat usage by the UK milling industry⁽¹⁾ in September 2019 was down 10.0% on year earlier levels at 562.5 thousand tonnes. The proportion of home grown wheat usage increased on the year by 5.3%, to 494.5 thousand tonnes.
 Imported wheat usage was down 56.2% to 68.1 thousand tonnes.
- From July to September 2019, UK millers⁽¹⁾ used 1.45 million tonnes of wheat, 16.3% lower than the same period in 2018/19. Of this, 1.24 million tonnes was home grown, a decrease of 4.1% year on year.
- In September 2019 UK brewers, maltsters and distillers used 160.3 thousand tonnes of barley, relatively unchanged (-0.3%) compared with the same period in 2018. At 61.4 thousand tonnes, the amount of wheat used by brewers, maltsters and distillers was 9.2% lower year on year.
