PLANT PROTECTION PRODUCTS REGULATION (EC) No 1107/2009

**AMENDMENT TO 'OTHER SPECIFIC RESTRICTIONS' FOR PRODUCTS
CONTAINING CHLORPROPHAM**

Date of issue: 9 April 2020

The Conditions of the Authorisations for the plant protection products listed in the Amendment Table have been amended as follows:

Use:

a) The existing OSR referring to total dose must be replaced by:

If the total dose applied (from any combination of products containing chlorpropham) is greater than 24 g chlorpropham/tonne, then treated potatoes must only be used for commercial processing, unless pesticide residue analysis confirms that the MRL of 10mg/kg is not exceeded.

In any case, the total dose applied (from any combination of products containing chlorpropham) to a stored ware potato crop must not exceed 36 g chlorpropham/tonne

b) In addition the following OSR must also be applied:

Where potatoes have been treated with chlorpropham at a total dose above 24 g/tonne they may only be released from the store into the fresh potato supply chain if pesticide residue analysis confirms that the MRL of 10mg/kg is not exceeded.

Samples of potato must be taken in line with the official sampling directive (EC 2002/63/EC) and analysed by a suitably accredited UKAS laboratory.

ALL OTHER CONDITIONS OF AUTHORISATION REMAIN UNCHANGED

1. This Amendment has been issued to amend the Conditions of Authorisation of the products listed.

Follow the EC sampling directive (EC 2002/63/EC): Samples should be taken from the lot to be put into the fresh market, random samples must be taken and the requirements of the directive complied with. A lot is defined as quantity of a food delivered at one time that has same: origin, producer, variety, packer, type of packing, markings.

3. Authorisation for sale and supply of these products expired on 8 January 2020. Storage and use of the products listed expires on 8 October 2020. These expiry dates are unchanged by this notice.
2. Expiry dates are subject to further decisions which may be made by Ministers.
3. This Notice will be published on the website of the Chemicals Regulation Directorate of the HSE.
