- Accurately knowing your costs of production can allow you to challenge your business decisions
  - · Machinery replacement and hire
  - Staff recruitment
  - Farm strategy
- Impact of potential loss of BPS payments phased to £0 by 2028
- · Benchmark your business to others on a comparable basis know where you stand
- · Highlight opportunities for cost saving, collaboration and diversification



#### Bridgnorth Monitor Farm – machinery costings



- A labour efficient arable enterprise with labour costs per hectare in the top 25%
- Sensible investment into a cultivation system that is well suited to the farm and consistently delivers performance.
- Staff appear to operate machinery and implements with care which minimises expensive repairs to drills.
- Labour is housed on the farm at a significant opportunity cost for the farm business.
- Yield performance must be maintained to offset the potentially higher costs of establishment.
- Good management knowledge and information provided. Generational planning well underway.
- A similar review may highlight the balance of costs associated with the dairy and beef rearing enterprises.

#### **Recommendations for Bridgnorth Monitor Farm**

- Ensure a structured replacement policy to avoid spikes in repairs and purchases, this may include a 10,000 hr tractor policy
- Ensure tax efficiency in utilising annual investment allowance to offset potential tax liabilities
- Potential to use the Amazone cultivator further to establish wheat
- Ensure yields maintained to maximise the farm performance
