

# Monitor Farm survey prize draw 2020

## Terms and conditions

1. The prize draw is open to all UK residents who have attended an AHDB Cereals & Oilseeds Monitor Farm meeting (England and Wales) and who complete a survey about the Monitor Farm scheme.
2. Only one entry per person (no multiple entries)
3. The competition is open for entries from 17/02/2020 and will close at 23:59 on 1/05/2020
4. Prize: one prize of a £50 food hamper. No cash alternative.
5. The prize draw can be entered by completing the Monitor Farm Survey online or on paper AND giving your name and at least one method of contact.
6. Postal entries should be either handed in to a member of AHDB staff at a Monitor Farm meeting or returned to AHDB, Stoneleigh Park, Kenilworth, CV8 2TL.

8. One winner will be chosen by a random computerised system from all entries correctly submitted in accordance with these terms and conditions.
9. The winner will be notified by their preferred method of contact, as indicated on their survey response, within seven working days of the closing date.
10. AHDB's decision will be final, and no correspondence will be entered into. By entering the survey prize draw, all entrants will be deemed to have accepted and be bound by the rules. All entry instructions form part of the rules.

12. The prize draw is open to participants aged 18 or over. Employees of AHDB and members of their immediate family are not eligible to participate.
13. The prize draw is run by the Agriculture and Horticulture Development Board, Stoneleigh Park, Kenilworth, Warwickshire CV8 2TL.
14. Your personal information: The survey itself is anonymous and the results will be used by AHDB to identify ways to improve its Monitor farm programme. The personal data we collect is your first name, county, country and a preferred way to contact you. This is only to enable AHDB to administer the prize draw competition and to deliver the prize to the winner. Three months after the end of the competition all personal data related to the competition apart from the winner's details will be deleted. A record of the winner will be retained for 7 years as part of the financial records related to the purchase of the prize. AHDB will ensure that there are appropriate technical and physical controls in place to protect your personal information. By law you have certain rights over your personal data that we hold, such as the right to be informed about how we use your personal information, the right to ask us to correct any errors, the right to ask for a copy of the personal information we hold about you and the right to object to AHDB's processing.
