

Demonstration of Life Assurance Scheme (Sheep and Goats)

Application Procedure

This document provides guidance to slaughterhouses wishing to participate in the Demonstration of Life assurance programme. Applications must be submitted to AHDB in the first instance. AHDB will then ensure that FBOs are made aware of the requirements and pre-requisites of the programme. The slaughterhouse will return the completed application form to AHDB (awal.fuseini@ahdb.org.uk). AHDB will check the completed application form before submitting it to the FSA via approvals@food.gov.uk. The FSA will then process a request for a non-refundable advance payment of £550.32 before veterinary supervision is arranged.

Pre-requisites

- DoL training conducted by AHDB
- DoL protocol read and understood
- Serviceable electrical stunning equipment (with maintenance records)
- Suitable method of restraint (V restrainer is acceptable)
- A penetrative captive bolt gun as backup stunner (with maintenance records)
- A suitable table to put animals on for post-stun DoL assessment
- Adequate facilities/space in the stunning/trial area to ensure the safety of staff during the demonstration
- A suitable video recording device (if required)

Time of trial

It will be necessary to ensure that all unwanted machinery and speaker systems are turned off during the trial to eliminate background noise. To minimise the impact of the trial on the operation of slaughterhouses, trials should be conducted at the start or end of the normal production run.
